

Congregation of St. Joseph
Sample Wills and Trust Language for Christ in the Wilderness, Inc.

The most common form of a planned gift is a bequest, which is in effect a gift made under your Last Will and Testament. Some donors may prefer to use Revocable (“Living”) Trusts as part of their estate plans to effect their testamentary gifts, which are referred to as distributions.

The Congregation of St. Joseph prefers all bequests (or distributions) for its sponsored ministries to be directed toward the congregation for use by the specified ministry. The sample language below will ensure that your desire to support Christ in the Wilderness, Inc. will be met.

In order to best maximize the use of your generous gift to Christ in the Wilderness, Inc., unrestricted gifts are most helpful to our ministries so they can be free to direct your gift toward their greatest need. Following you will find language for both unrestricted and restricted language for wills and trusts.

SPECIFIC WILLS/TRUST LANGUAGE

LANGUAGE FOR UNRESTRICTED GIFT USE

Language for a Gift of a Specific Dollar Amount Under Will

I give, devise and bequeath to the Congregation of the Sisters of St. Joseph, Inc., a West Virginia corporation, or its successor (the “Congregation”), the sum of \$_____ [or property described herein] to be used by Christ in the Wilderness, Inc., an affiliated Illinois corporation, or its successor, in its discretion for its general purposes. If it is determined by the Leadership Team of the Congregation that all or part of the gift is no longer needed, or for any reason cannot be used for the general purposes of Christ in the Wilderness, Inc, then such portion of the gift may be used for the general purposes of such other ministry as the Leadership Team deems to be in the best interests of the Congregation, giving consideration to the original ministry selected.

Language for a Distribution of a Specific Dollar Amount
Pursuant to Revocable Trust

My trustee shall distribute to the Congregation of the Sisters of St. Joseph, Inc., a West Virginia corporation, or its successor (the “Congregation”), the sum of \$_____ [or property described herein] to be used by Christ in the Wilderness, Inc., an affiliated Illinois corporation, or its successor, in its discretion for its general purposes. If it is determined by the Leadership Team of the Congregation that all or part of the gift is no longer needed, or for any reason cannot be used for the general purposes of Christ in the Wilderness, Inc, then such portion of the gift may be used for the general purposes of such other ministry as the Leadership Team deems to be in the best interests of the Congregation, giving consideration to the original ministry selected.

**Language for a Gift of the Residue or Percentage of the Residue
of an Estate Under Will**

I give, devise and bequeath all the residue of my estate [or ___ percent (___%) of the residue of my estate] to the Congregation of the Sisters of St. Joseph, Inc., a West Virginia corporation, or its successor (the "Congregation"), to be used by Christ in the Wilderness, Inc., an affiliated Illinois corporation, or its successor, in its discretion for its general purposes. If it is determined by the Leadership Team of the Congregation that all or part of the gift is no longer needed, or for any reason cannot be used for the general purposes of Christ in the Wilderness, Inc, then such portion of the gift may be used for the general purposes of such other ministry as the Leadership Team deems to be in the best interests of the Congregation, giving consideration to the original ministry selected.

**Language for a Distribution of the Residue or Percentage of the Residue
of Trust Property Pursuant to Revocable Trust**
